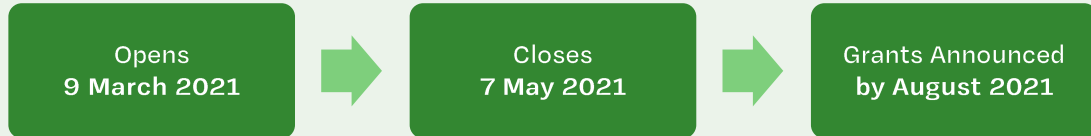
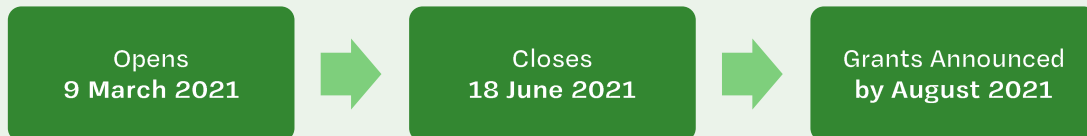

Program Information

Program Purpose

FRRR and the Vincent Fairfax Family Foundation (VFFF) have a shared belief in the critical role of not-for-profit (NFP) organisations in building and supporting vibrant communities, both socially and economically. So, it is essential that these critical organisations are resilient and able to support and respond to community needs.

We also recognise that all too often, funding for NFPs is tied to a particular project or dependent on external fundraising. This approach supports NFPs' abilities to retain and invest in their organisation through their people, processes, and systems. The Investing in Rural Community Futures (IRCF) program seeks to invest in individual organisations' long-term viability, which



in turn will have a positive impact on community well-being. The program also looks to promote collaboration between NFPs and identify common goals and needs, leading to potential joint projects. IRCF takes a long-term approach to strengthening local NFP organisations, providing support over a five-year period, through both grants and other support and resources. Funded until 2023, the program has the ability to fund multi-year projects.

As part of the IRCF program, FRRR is inviting applications for Ongoing Partnership grants to assist the communities of **Junee** and **Nambucca Valley**.

Types of Projects Supported

IRCF funds projects aligned with the following types of charitable projects and outcomes:

- Training for NFP Committees / Boards - for example governance; financial, digital literacy, marketing.
- Paid positions where needed - for example to develop and embed policies / procedures; financial systems and processes; evaluation frameworks and processes.
- Skilled support - including strategic / business planning / implementation; financial analysis and planning; resource sharing / collaborative delivery approaches; investigating different models such as social enterprises.
- Future actions / visioning - such as feasibility options for future service needs; scoping of initiatives to drive long term community viability and strengthen NFPs; exploring collective impact approaches to local issues.
- Equipment and materials to support your organisation's sustainability and organisational effectiveness.
- Costs to come together and share, network and build the profile of the NFP sector.
- Succession planning for key roles, recruitment of volunteers and member.
- Development of staff and leadership positions.
- Refreshment of brand, website, and marketing aspects.

Where it makes sense, it is highly recommended NFPs work together to identify how to maximise the use of these funds and how this can support their organisations.



What

can't be
used for

There are several areas that we **can't fund** through this program. If in doubt, please contact us.

- Projects that support core business and areas of responsibility of Federal, State and Local Governments.
- The encouragement or advancement of sport, recreation and social activities are not considered charitable activities under Australian law. Applications from sporting organisations need to clearly demonstrate charitable outcomes and benefit to the wider community that are above and beyond the sporting activities of the club.
- Overseas travel and overseas projects;
- Prizes, gifts, trophies or awards;
- Political lobbying;
- Projects that primarily benefit private business, a sole trader, or private interests;
- Projects solely focused on animal welfare.

PLEASE NOTE: Organisations that receive funding through the IRCF program are not eligible to apply for other FRRR grants for the duration of the program, except for recovery funds for natural disasters.

Eligibility

To apply, you must meet the following criteria:

- Applicant organisations must be a **locally governed not-for-profit** organisation in Junee or the Nambucca Valley **with an ABN or Incorporation Certificate**;
- Project must be for charitable purposes and offer clear local benefit;
- Organisations with or without DGR endorsement are eligible;
- Projects must benefit communities in remote, rural, or regional Australia.

Please note, you will be considered ineligible if the:

- Application is submitted by individuals, sole traders, private or commercial businesses (as per the submitted ABN);
- Application is submitted by an organisation that is not a legal entity (i.e. a registered not-for-profit), without the written consent of the governing / partnering body who holds the ABN / Incorporation Certificate;
- Application is submitted without required financial documentation;
- Application is for a project or activity that has already occurred / is occurring prior to the announcement of funding.
